# REGULATIONS FOR THE CONTROLLING COMMISSION AT THE OLYMPIC GAMES AND CHAMPIONSHIPS

### **Article 1**

Established in execution of articles 20 and 32 of the Constitution  
In view of the General Regulation for events and international competitions,  
In view of the Refereeing Regulation,  
In view of the Internal Regulation,  
In view of the Disciplinary Regulation,

The present Regulation aims at setting the rights and obligations of the members of the FILA Bureau and the competent specialists that are appointed to the Control Commission – the Supreme Court – at the occasion of the Olympic Games and the International Championships.

### **Article 2**

The present Commission aims at ensuring the good course of the competition as well as examining and controlling, objectively and considering the Regulation, that the judges and the referees do perfectly interpret and apply the wrestling rules. The Commission also aims at submitting penalties proposals as well as categorization of referees together with the President of the Technical Commission and the President of the Refereeing Commission.

### **Article 3**

During every Olympic Games or International Championships, one or several controllers will be designated for that very purpose by the FILA President or his representative. Their number will vary in accordance with the needs and the number of mats used during the competition.

This designation will be secret. Only the Members of the FILA Bureau and the recognized specialists can be designated. Permanent Members are the following:

- the President of the Technical Department,
- the President and the Secretary of the Refereeing Commission,
- the President and the Secretary of the Legislative Commission.

### **Article 4**

It is the duty of the controllers to take any measure required by the partial or incompetent behaviour of the judges or referees and to act in order to obtain the most correct result of the bout.

### **Article 5**

FILA controllers are invested with the most extended discretionary power.

Each controller can, when required by the circumstances, investigate a sanction procedure against one or several members of the Refereeing Body, according to the following criteria:

- a) Qualification and competence,
- b) Impartiality and honesty
- c) Work at the respect of the spirit of new rules
- d) Body movements and behaviour

### **Article 6**

When the retrogression of the Judges and the referees is planned, the controllers will present their own opinion to the President of the Control Commission about the work and the behaviour of the guilty referees, independently from the Mat chairmen's opinion.

In case of a serious error, sanctions will be imposed immediately, with the agreement of the Members constituting the permanent Commission.

These sanctions consist in a warning, a partially or total dismiss of the competition and a retrogression.

#### **Article 7**

The Members of the Refereeing Commission can be consulted if the controllers consider useful to do so. Every day the President of the Refereeing Commission will hold a meeting with the referees in order to analyze the mistakes and inform them with the sanctions taken.

#### **Article 8**

At the end of each session, the controllers, in presence of the Members of the Refereeing Commission, must gather the refereeing body together in order to inform them on their critics and eventually on the sanctions that will be asked against some of them.

#### **Article 9**

The Appeal Jury is set up by the group of controllers in case of contesting.

If a protest is not filed and an important refereeing mistake has been noticed by one or several Members of the Commission, the aforesaid Commission can proceed to the examination of the video of the bout.

The result cannot be changed.

On the other hand, if the refereeing mistake is duly noticed, the persons at fault can be penalized.

#### **Article 10**

At the end of the year and based on the recorded information, the new list of categorization of referees will be established.
