Following the 2015 Senior World Championships, a first selection of officials for Rio 2016 was made.

In order to train and educate them, a referee course will be organized in Sochi (RUS) from the 8th to the 13th of December 2015. *Please refer to the schedule below to know your exact arrival date as each role don't have to be there at the same time.*

The Russian Wrestling Federation will welcome you at the Sochi airport. I thank you therefore in advance to confirm their availability for this course and inform the Russian Wrestling Federation of their exact arrival and departure times in order to arrange their transfers to the hotel.

The accommodation fee is 70 Euros per person per night (board and lodging). Payment has to be effected to a representative of Wrestling Federation of Russia upon the participants' arrivals.

United World Wrestling will cover the travel and accommodation fee for the Instructors and Supervisors but all of them need also to confirm their participation to Jean-Daniel Rey (jeandaniel@unitedworldwrestling.org) and book their travel with Beg Tours (Begetours@EUnet.rs). These confirmations have to be returned to United World Wrestling and the Russian Wrestling Federation for the 7th of November 2015.

For all the participants who need Visa Support letter, we kindly ask you to contact directly the Russian Wrestling Federation.
